Students at Shell Point Elementary School and Hilton Head Island Elementary School have recently learned that their applications for KITE-LL language curriculum have been accepted. KITE-LL is a free, hybrid distance learning language program produced by ETV and the SC Department of Education that combines pre-taped video lessons with face-to-face instruction and assessments. The thirty week daily program is geared for students in grades 3 to 5 and offers Spanish, German and French instruction. Our students will be enrolled in the Spanish language program. KITE-LL is the first foreign language distance-learning program for elementary school

students that draw from grade-level content standards (primarily social studies, language arts, science, and mathematics) to teach French, German, and Spanish. We are very excited about this addition to our world language curriculum.

Board Members Fred Washington and Herbert Burnes were recognized for levels of training and service to the Beaufort County School Board.

#### **Comment Corrections**

Dr. Truesdale explained the confusion surrounding the distribution of pocket constitutions On August 6, 2010 the Island Packet ran a story with headlines that caused concern by some citizens. The story described an offer made by the Hilton Head Island Tea Party to donate pocket Constitutions to students in middle and high school in time for Constitution Day on September 17.

When the offer of a donation was made in late July, the intent was so that each student would have his/her own copy of the Declaration of Independence and the Constitution of the United States, including the Bill of Rights. The district responded to the offer that instructional materials had to be reviewed prior to distribution and that donations were typically approved by the Board of Education, especially if the donation were in excess of \$1,000.

We committed to reviewing the materials when submitted and determine if they were appropriate for sharing with students and to reviewing the offer with principals.

The headline indicated that Tea Party members would be teaching the Constitution to students and that is untrue false. Teaching the Constitution by anyone other than Beaufort County School District teachers was not considered at any time. The article is clear that teaching by citizens had not been discussed but the headline said otherwise and caused concern.

When the actual pocket Constitution offered for donation was received last week, it was reviewed by staff. We determined that since there were identifying marks on the materials, specifically stating that the materials were provided compliments of a Congressman, we would not distribute those to our students.

Instead, we are obtaining pocket Constitutions directly with no identifying marks upon them. The materials contain only the Declaration of Independence, and he Constitution including the Bill of Rights. Materials will be used as part of the study of authentic documents in Social Studies and History classes.

Chairman Washington, Secretary Laura Bush and Board Member Earl Campbell made comment corrections regarding the misrepresentation of information in an online newspaper and are committed to getting the facts out surrounding the false statements and inaccuracies in public comments.

- To audit insurance certificate policies, procedures and compliance
- To audit policies, procedures and compliance in obtaining lien releases prior to final payment on contracts

### **Superintendent's Report**

Superintendent Dr. Valerie Truesdale updated the Board on the opening of school and highlights of the first couple of days.

Director of Operations gave a brief update along with Durham Services on the challenges the district faced with regards to transportation and a plan to correct procedures and increase communication among drivers, Durham, parents, principals and students.

Student Services Officer, Dr. Cynthia Hayes, submitted the performance expectation to participate in diverse community activities and events as an advocate for all students. Dr. Hayes reported on the number of meetings and events held in the previous school year with community groups attended by the Superintendent along with members of the staff.

Chief Administrative and Human Resources Services Officer Dr. Jackie Rosswurm presented Performance Expectation 6:A.5, under the Strategic Governance Policies, which states: Inform the Board when initially recommending individuals to administrative level position or general contracting positions who are immediate family members of the Superintendent, Executive Leadership, or Principals.

It was requested at the last Board of Education Meeting (August 3, 2010) that this Performance Expectation come to the Board for revision.

Chief Operational Services Officer, Phyllis White gave an update of the FY 2010-2011 Budget. Vice Chairman, Bob Arundell, asked that the information be presented in such a way that it is understood by all stakeholders.

#### **Board Business Action**

Vice Chairman, Bob Arundell, made a motion to authorize the issuance and sale of not exceeding \$2,750,000 general obligation bonds, in one or more series, with appropriate series designations, including a tax-exempt series and a taxable series, of the school district of Beaufort County, South Carolina; authorizing the South Carolina Association of Governmental Organizations to facilitate the sale of the bonds under its general obligation debt program; prescribing the terms and conditions under which the bonds may be issued; authorizing the Superintendent of the school district to determine certain matters relating to the bonds; providing for the payment of the bonds and the disposition of the proceeds thereof; and other matters relating thereto. Motion passed.

Riverview Report – Alison Thomas presented Riverview Annual Report. Board Members had questions regarding the MAP data and demographics. Riverview will provide information the Board is seeking.

Board Member Michael Rivers led a discussion regarding the classified salaries. Board Member Jim Bequette made a motion to table the discussion until the administration has an opportunity to present to the Board the chronology of the last human resources salary study and the implementation of that classified salary study. Motion passed.

Board Secretary Laura Bush made a motion to approve the consent agenda excluding the July 23, 2010 and July 24, 2010 minutes.

Vice Chairman, Bob Arundell made a motion to move back into executive session to discuss a legal matter.
