Dr. Truesdale continued:

Our Youth Leadership Academy is meeting once again at Bluffton Middle School and Robert Smalls Middle School. This is a new initiative this summer that teams male emerging and school leaders from our middle schools and provides activities and opportunities to stretch their abilities to lead. This is the second week this summer that the students have met — one week in June one in August. The program focuses on Sean Covey's Seven Habits of Highly Effective Teens. The students are working this week on preparations for a successful school year. We thank our board members, Mr. Speaks, Mr. Wilson and Mrs. Bush, for stopping by and speaking to our students this week. Your support of this project is greatly appreciated.

Showcase:

Amy Tressler, Naturalist with the Coastal Discovery Museum, addressed the board regarding the recent **Coastal Discovery Camps** held for Beaufort County students in conjunction with the Coastal Discovery Museum. The two camps, one in the Beaufort area and one at the Coastal Discovery Museum on Hilton Head, were weeklong for students in grades 3-5. There were 48 students who participated.

Dr. Alford presented his **2011 Adequate Yearly Progress Report, PE 8.4.** He reported that seven Beaufort County Schools made AYP this year in comparison to sixteen last year. The reason for the drop was that the standards increased significantly this year. This was a common trend throughout the state. As a whole, the District achieved 31 of 33 objectives. The Board had several questions regarding the data.

Dr. Alford also reported that Advanced Placement data had been received. The 2010-2011 data shows that gains had been made in three of 4 high schools for the percentage of AP scores of 3 or higher.

Superintendent's Report:

Dr. Truesdale presented to the Board the Semi-Annual Sole Source/Emergency Procurement Update. Action on the item will be taken at the next Board Meeting.

Dr. Truesdale presented the guidelines for student fees and supply lists. Mrs. Bush had requested the information so that the Board could review in light of the economic downturn and what parents could afford to spend. There was discussion by the Board.

Dr. Rosswurm presented the Annual Assessment Calendar from Riverview. The Board reviewed. Discussion followed. Mr. Morello asked Dr. Rosswurm if the Board could get an update on hiring data from Riverview.

Chairman's Report -

Mr. Washington spoke about the highly successful School Expos held in recent weeks North and South county. He expressed his gratitude to all of the businesses who donated food, prizes, and school supplies.

Mr. Washington reported that he had attended a recent ROAR (Reduce Our Awful Taxes) meeting and urged others to get involved in the ROAR movement.

Mr. Washington asked the approval of the Proposed Protocol for PE 9 – Community Relations be discussed at the next meeting.

New Business
