## Ms. Bucci-

Upon our receipt from you of the deposit referenced below, the District will make public records responsive to this request available to you under the FOIA, §30-4-30, subject to the exemption and redaction of records that are exempt from disclosure pursuant to the FOIA, including §§ 30-4-40(a) (2), (4), (5), and (7) and (13). The District is also unable to produce confidential student educational records, as they are protected from disclosure under the Family Educational Rights and Privacy Act ("FERPA"), 20 U.S.C. § 1232g.

The search query for your first two requests returned 536,165 emails. In accordance with S.C. Code Ann. 30-4-30(B), the BCSD estimates search, retrieval, and redaction, if necessary, of documents to respond to your request will require 2,681 hours, for an estimated cost of \$107,555, plus 6 cents per copy. If we estimate 2 pages per email copying charges will be \$64,340. Costs may increase or decrease. A 25% deposit of the total reasonably anticipated cost is required before work will begin on your request. Please make all checks out to the Beaufort County School District and send to my attention.

Please consider narrowing your request to be more specific to include information about each record sought, such as the date, title or name, author, recipients, and subject matter of the records and resubmit your request.

Regarding your third request, we currently extract the information that can be made public and post it on the BCSD website. At the elementary or secondary level, a student's health records, including immunization records, maintained by an educational agency or institution subject to FERPA, as well as records maintained by a school nurse, are "education records" subject to FERPA. At the elementary or secondary school level, students' immunization and other health records that are maintained by a school district or individual school, including a school-operated health clinic, that receives funds under any program administered by the U.S. Department of Education are "education records" subject to FERPA, including health and medical records maintained by a school nurse who is employed by or under contract with a school or school district. Some schools may receive a grant from a foundation or government agency to hire a nurse. Notwithstanding the source of the funding, if the nurse is hired as a school official (or contractor), the records maintained by the nurse or clinic are "education records" subject to FERPA. Parents have a right under FERPA to inspect and review these health and medical records because they are "education records" under FERPA. See 34 CFR §§ 99.10 – 99.12. In addition, these records may not be shared with third parties without written parental consent unless the disclosure meets one of the exceptions to FERPA's general consent requirement. Attached is a summary of FERPA exemptions of which media is not included.
