Voters in districts countywide sent the strongest signal of the day. They totally wiped out the old regime running the Beaufort County School District. Gone are former superintendent Jeff Moss, who resigned with a golden parachute this summer, and all his chief

supporters on the school board. Incumbents Evva Anderson placed third below two new challengers in Bluffton, and Cynthia Gregory-Smalls was trounced on St. Helena Island. The people didn't merely speak, they shouted.

With three members of the "Moss Majority" thankfully not seeking re-election, the clean sweep is in place. Now the new board must live up to its promise by conducting public policy in public, and by treating each other with respect.

Never before has the Beaufort County public needed and deserved change like this, and the new board must deliver.

What is really exciting;

Our newly established board has the opportunity to elect new leadership, return respect to our school district, regain the necessary trust of the electorate and hire a new superintendent. A heavy load indeed.
