



State Park officials assessing St. Phillips Island

The State Park Service is currently assessing the resources and logistical capacities of St. Phillips Island to develop a comprehensive management plan for the property.

Last December, in what is considered to be one of the most important conservation transactions in state history, environmentalist and philanthropist Ted Turner sold the 4,680 acre island to the State of South Carolina for only \$4.9 million; a deal that will add more public beach access and camping to Beaufort County.


Once that plan is in place, a strategy will be established to optimize the visitor experience potential as part of Hunting Island State Park.


Hunting Island State Park to grow almost 5,000 acres

In what is considered to be one of the most important conservation transactions in state history, environmentalist and philanthropist Ted Turner and the state of South Carolina closed Wednesday on the charitable transfer of Turner's 4,680-acre St. Phillips Island near Beaufort via a bargain sale; a deal that would add more public beach access and camping in Beaufort County.

As the largest privately held island off the coast, St. Phillips was sold for \$4.9 million, about one-third of its appraised value and will complement Hunting Island State Park nearby. The sale was cleared within the last two weeks by the Joint Bond Review Committee and the State Fiscal Accountability Authority.

Simply put, Hunting Island State Park grows by adding St Phillips Island.

"St. Phillips is a jewel off the South Carolina coast, a pristine barrier island suffused with the natural beauty of the Lowcountry," said Duane Parrish, Director of the South Carolina Department of Parks, Recreation & Tourism, which will manage the island. "The possibilities for shaping and offering exceptional coastal experiences are numerous."

Historic Hallowed Ground: Beaufort's First African Baptist Church

Built in 1865 by freed slaves, the First African Baptist Church of Beaufort has been the spiritual focal point of its community for over 150 years.

A local white Baptist congregation built an earlier church on the property that was used as a praise house for slaves. After the Emancipation Proclamation in 1863 and the end of the Civil War two years later, those former slaves bought the land and built a new church that stands today, mostly in its original form.

A marble plaque on the church recounts its opening history: "Presented as a token of respect by A.D. Deas to the first and present pastor, Reverend A. Waddell, of the First Baptist Church, a native of Savannah, Georgia, who became pastor of said church First of January, 1865."

Among the church's earliest members was Robert Smalls, an African-American hero of the Civil War and a US congressman during Reconstruction. A monument to Smalls is on the church grounds.

Ne	w Year's I	Day brings	year's first	supermoon

New Year's day 2018 also brings the year's first supermoon to the sky over Beaufort. This one's nicknamed a wolf moon. It's not just the first one of the year, it's also the first of two of them in January 2018. It'll be closely followed by another just weeks later on the 31st...with a special bonus.

A supermoon occurs when the moon appears bigger and brighter in the sky when it becomes full on the same day that it reaches its perigree, the point in the moon's elliptical orbit when closest to Earth.

During a supermoon, the moon generally appears to be 14% bigger and 30% brighter than a typical full moon occurring approximately every 13 months, according to NASA.

The second supermoon is coming on January 31st, making it a blue supermoon. You've undoubtedly heard the phrase, "once in a blue moon'. Well, a blue moon occurs about once every two and a half years.

According to NASA, the January 31st supermoon will also feature a total lunar eclipse; when the Earth, sun and moon, line up with the Earth blocking the sunlight that normally reflects off of the moon.
