The total annual increase in facilities maintenance shall be $\$ 125,619.30$.
The proposed staffing additions/upgrades will be:

1. Promote the existing South of the Broad general tech to full time plumber,
2. Add one additional general tech to replace the promoted employee
3. Add one preventative maintenance tech to allow formation of two -2 person crews,
4. Add one mover.

The total number of GCA maintenance hourly employees will increase from 41 to 44.
