Amended motion to copy the Board on all communication between SCDE and the Superintendent. Board discussion. Amended motion approved. Motion that local Board responsibilities and objectives of the MOAs be directed to the Academic Committee. Board discussion. Motion approved.

Whale Branch Middle Principal Freddie Lawton provided an update on the priority school MOA and addressed the Board's questions. The September 17 Board meeting will be the next update from both the Priority and TSI schools.

Board Business

FY2019-2020 Budget Re-Certification

Chief Financial Officer Tonya Crosby presented an update from County Council's first reading and an updated budget for recertification and presentation for County Council second reading on June 17. Dr. Berg shared that County Council will vote for a surcharge if the district splits it in two and comes back with a budget of \$254 million (cut of another \$1 million). Dr. Berg and Ms. Crosby addressed the Board's questions. Motion to certify the FY 2020 operating budget removing Line 20 (reduce 15 instructional coaches in the amount of \$1,394,539) for a total expenditure amount of \$254,297,442. Board discussion. Motion approved.

Discussion of Interim Superintendent and New Superintendent Contracts

Dr. Berg updated the Board on Dr. Rodriguez's recent visit to the District. The Board discussed Dr. Rodriguez's pre-employment services per his contract. Motion to approve 10 days for Dr. Rodriguez to visit the district before July 1. Board discussion. Motion approved.

Dr. Berg's last day will be June 30.

Public Comment

A district school principal spoke against budget cuts that would reassign instructional coaches as classroom teachers.

Announcements

There will be a special called meeting to discuss the referendum on June 18 at 6 p.m. at the district office. Board discussion.

Motion to adjourn approved. Meeting adjourned at 10:05 p.m.
