The monitor I purchased does not read levels of formaldehyde (HCHO) in excess of 1.999. As you can see in the attached image, the levels reached the max (1.999) which is the monitor's top reading. We have no idea how much higher the HCHO reading would have registered if the unit had the ability to read the correct number. We do, however, know that clearly it is at least 200 times above the acceptable limit.

The monitor also does not read TVOC (Total Volatile Organic Compounds) above 9.999. Again, the monitor maxed out leaving us unaware how much above that number the air really contains. It is clear in my research that once these substances are at a level to cause a noticeable smell you are well beyond the safe and acceptable limits for exposure.

According to all reputable resources, <u>including OSHA</u>, the maximum acceptable level for formaldehyde exposure is 0.010. As stated the levels in this classroom are over 200 times greater than acceptable levels. I fear what the actual levels are using a monitor that can read beyond the maximum numbers of my unit, but one thing is certain, having children being exposed to this <u>8 hours</u> a day for <u>180 days</u> is making our children ill AND putting the district at a huge liability.

By sending this email I have proof the district and board has been made aware of the problem. Choosing to continue to put the health of the children and teachers at risk would be nothing short of gross negligence on your part. There are many air purifiers on the market that do not produce ozone and are meant for removing formaldehyde and VOCs. They are

not inexpensive units. They will cost near \$1000 dollars per classroom, but we are discussing over 150 children's lives that are potentially affected. The dollar amount should have no bearing. These children deserve to go to school without having to risk their long term health to do so. I feel certain as a district that you would not want this environmental debacle to happen on your watch especially knowing the extreme liability the district would have by being aware of this problem and then choosing to ignore it. We have all seen the cancer clusters that can develop years after a group is exposed to dangerous substances. WHO signed off on the safety of these classrooms? We need full disclosure as but more importantly an expedient correction of a toxic situation. Airborne substances that are so strong they are actually permeating children's clothing? This is beyond unacceptable.

I realize and accept that this problem likely can't be totally eliminated since clearly you tried to remediate the smell this summer and that did not work. It can, however, be improved through the immediate purchase and use of air purifying units being added to each of the classrooms including the hallway since teachers often have their doors open. The selection of these purifiers should be made by a knowledgeable person in this area and professionals that can install them correctly and maintain them with clean filters when necessary.

I am including a list of companies that build units specifically for these airborne contaminants. Again, they are not cheap, but the lives of our children are worth far more.

I am hoping this can be remedied by providing the district and board this information so that <u>immediate</u> action can be taken. If action is not taken promptly to ensure the health of these students I will be forced to reach out to local media to help inform the other parents about what their children are being exposed to on a daily basis as well as letting the general public know the liability the district has placed on itself by not addressing this clear and obvious problem. It doesn't take more than a second of walking into those portable classrooms to know there is a problem, clearly one that has been being ignored at the sake of our children's health and well-being. I truly hope to see swift and immediate action to remedy this problem and provide these children an environment that is not dangerous to their health.







By sending this email I have proof the district and board has been made aware of the problem. Choosing to continue to put the health of the children and teachers at risk would be nothing short of gross negligence on your part. There are many air purifiers on the market that do not produce ozone and are meant for removing formaldehyde and VOCs. They are not inexpensive units. They will cost near \$1000 dollars per classroom, but we are discussing over 150 children's lives that are potentially affected. The dollar amount should have no bearing. These children deserve to go to school without having to risk their

long term health to do so. I feel certain as a district that you would not want this environmental debacle to happen on your watch especially knowing the extreme liability the district would have by being aware of this problem and then choosing to ignore it. We have all seen the cancer clusters that can develop years after a group is exposed to dangerous substances. WHO signed off on the safety of these classrooms? We need full disclosure as but more importantly an expedient correction of a toxic situation. Airborne substances that are so strong they are actually permeating children's clothing? This is beyond unacceptable.

I realize and accept that this problem likely can't be totally eliminated since clearly you tried to remediate the smell this summer and that did not work. It can, however, be improved through the immediate purchase and use of air purifying units being added to each of the classrooms including the hallway since teachers often have their doors open. The selection of these purifiers should be made by a knowledgeable person in this area and professionals that can install them correctly and maintain them with clean filters when necessary.





Dr. Rodriguez,

Here is where I am:

I am letting you know what we have done today to address the possible issue with formaldehyde in the mobiles at RRA.

- 1. Our indoor air quality consultant, Terracon, was contacted to find out the hazards associated with formaldehyde in mobiles.
- 2. Formaldehyde tests have been ordered for all mobiles purchased in the last two years.
- 3. An investigation (and I know you have as well) of the mobiles for the presence of an odor.
- 4. Quickly researched public health data on the presence and hazards of formaldehyde.
- 5. Researched school health records to symptoms that match the hazards associated with formaldehyde.
- 6. Contacted the mobile manufacturer to find out if what formaldehyde standards have been met.
- 7. Investigated the test results of the equipment used by the concern parent.
- 8. We have contacted the concern parent to visit with them at the school to review their concerns and let them know our game plan.

At this time, I am unable to substantiate a concern related to the use of the mobiles. Formaldehyde tests to be completed on Monday will provide valuable information. Test will be sent off to a lab to analyzed with results returning by late Wednesday. We have put everything on a fast track for completion and this is unfortunately the quickest these test are capable of being completed.

Here is a summary of our findings and research:

- There is a slight odor in the mobiles. Our indoor air quality consultant is not concerned with this smell. He will be on site Monday to verify.
- We are unable to find data stating that formaldehyde discharge in mobiles is a current issue. There have been issues with formaldehyde release in the past, however present tests have found that this is no longer being found in mobiles as a concern. Example research material from the National Institutes of Health is attached.
- Our indoor air quality consultant had not heard of recent issues with formaldehyde in mobiles. They stated that this was an issue 10-15 years ago, but were unaware of recent issues.
- Exposure to formaldehyde is found to cause headaches, nose bleeds, and scratchy eyes.
- Researched the presence of headaches, nose bleeds, scratchy eyes within the school and found no statistically significant difference between students in the mobiles and in the main building.
- The indoor air quality consultant stated that they were familiar with the testing equipment used by



Thank you for reaching out and for your concern regarding this matter. While I appreciate the offer to meet with you I will have to respectfully decline. I am not an expert in this matter. Rather a parent with some common sense that when children are showing these symptoms and coming home smelling strongly like the environment they are being schooled in there is a problem. Through just basic research into the things that can cause this in mobiles it led me to purchase the particular monitor I chose. There may be other issues and the issues may be far more severe than indicated by this monitor.

I firmly feel that the use of the monitor I have will do nothing to help determine the severity of the matter. I believe a true, professional air quality test with higher limits to their readings is necessary to determine the extent of this issue. I have no training or education in the remediation of such substances but I know there are people that do and trust the district has the resources to bring in professionals to ensure the health of our children and teachers.

I appreciate the expediency with which you are trying to move with this. I do also understand that this will not be an overnight fix. As stated the levels in this classroom are over 200 times greater than acceptable levels. 



It is clear in my research that once these substances are at a level to cause a noticeable smell you are well beyond the safe and acceptable limits for exposure.

According to all reputable resources, <u>including OSHA</u>, the maximum acceptable level for formaldehyde exposure is 0.010. As stated the levels in this classroom are over 200 times greater than acceptable levels. I fear what the actual levels are using a monitor that can read beyond the maximum numbers of my unit, but one thing is certain, having children being exposed to this 8 hours a day for 180 days is making our children ill AND putting the district at a huge liability.

By sending this email I have proof the district and board has been made aware of the problem. Choosing to continue to put the health of the children and teachers at risk would be nothing short of gross negligence on your part. There are many air

purifiers on the market that do not produce ozone and are meant for removing formaldehyde and VOCs. They are not inexpensive units. They will cost near \$1000 dollars per classroom, but we are discussing over 150 children's lives that are potentially affected. The dollar amount should have no bearing. children deserve to go to school without having to risk their long term health to do so. I feel certain as a district that you would not want this environmental debacle to happen on your watch especially knowing the extreme liability the district would have by being aware of this problem and then choosing to ignore it. We have all seen the cancer clusters that can develop years after a group is exposed to dangerous substances. WHO signed off on the safety of these classrooms? We need full disclosure as but more importantly an expedient correction of a toxic situation. Airborne substances that are so strong they are actually permeating children's clothing? This is beyond unacceptable.

I realize and accept that this problem likely can't be totally eliminated since clearly you tried to remediate the smell this summer and that did not work. It can, however, be improved through the immediate purchase and use of air purifying units being added to each of the classrooms including the hallway since teachers often have their doors open. The selection of these purifiers should be made by a knowledgeable person in this area and professionals that can install them correctly and maintain them with clean filters when necessary.

I am including a list of companies that build units specifically for these airborne contaminants. Again, they are not cheap, but the lives of our children are worth far more.

I am hoping this can be remedied by providing the district and board this information so that <a href="immediate">immediate</a> action can be taken. If action is not taken promptly to ensure the health of these students I will be forced to reach out to local media to help inform the other parents about what their children are being exposed to on a daily basis as well as letting the general public know the liability the district has placed on itself by not addressing this clear and obvious problem. It doesn't take more than a second of walking into those portable classrooms to know there is a problem, clearly one that has been being ignored at the sake of our children's health and well-being. I truly hope to see swift and immediate action to remedy this problem

and provide these children an environment that is not dangerous to their health.
