

Report by Protective Services Officer David Grissom (January 25, 2019)

In April 2016, I was contacted by Lt. Brian Baird, Special Investigator for the Beaufort County Sheriff's Office (BCSO), in regards to an alleged adulterous relationship between Principal O'Nan and Staff Sgt. DeJuan Holmes that may have occurred at Hilton Head Island High School. A meeting was arranged later that day, and district General Counsel Drew Davis and I went to the BCSO, where we met with Lt. Baird.

Lt. Baird shared with us that he had received a complaint from the husband of Amanda O'Nan (Chris O'Nan) that alleged an adulterous relationship between Staff Sgt. DeJuan Holmes and Principal Amanda O'Nan. Lt. Baird advised that he was conducting an administrative inquiry and wanted us to be aware that some of the allegations included sexual activity at Hilton Head High School.

Mr. Davis and I returned to the district office, where we met with Superintendent Jeff Moss. I was excused from the office, with Dr. Moss stating that he would handle this himself. I left the office and never spoke to Dr. Moss or Drew Davis again about the inquiry.

On Tuesday, January 8, 2019, I was asked by district Chief Administrative and Human Resources Officer Alice Walton about the incident and was told that there would be a meeting in her office the following day at 9 a.m.

On Wednesday, January 9, I met with Ms. Walton and district General Counsel Wendy Cartledge and reviewed the BCSO inquiry into the above-mentioned allegations. The reports include the BCSO's initial investigation in 2016, which ended when Staff Sgt. Holmes resigned. The next BCSO report was from June 2018, when the inquiry was reopened by the BCSO (reports attached).

During the course of my investigation, I reviewed the initial statement given by Chris O'Nan on May 2, 2016, to Lt. Baird. In his statement, Mr. O'Nan stated

I reviewed a statement given by Mr. Holmes on June 21, 2018. In that statement, he admitted to a sexual relationship with Amanda O'Nan and further advised that some of the

sexual encounters occurred inside the high school. Mr. Holmes also admitted that during this time he would allow Amanda O’Nan to ride around with him in his police vehicle while he was on duty and against BCSO policy.

I attempted to contact Mr. Holmes directly via his phone and left several messages that went unanswered. Through his wife, Alice Walton was advised that Mr. Holmes did not want to make any further statements.

I contacted Mr. O’Nan, who stated that these events had already done enough damage to his children, and he wanted to stay out of it. He said he would have no further comments and would provide no assistance.

Mr. O’Nan did say that his private investigator had photos of Amanda O’Nan and Mr. Holmes while the two were at Hilton Head Island High School, I contacted the investigator, who declined to provide any surveillance photos.

I reviewed a statement given to BCSO by Karen Anderson. Ms. Anderson stated

I reviewed activity involving the electronic building access badge issued to Amanda O’Nan. Records indicated that Ms. O’Nan used her access badge on a regular basis at the high school during the 2014-15 school year. During the 2015-16 school year, her access badge was used frequently until Dec. 3, 2015. There is no activity on her access badge from Dec. 3, 2015 until Feb. 17, 2016, when her badge was automatically disabled due to lack of use. She attempted to use her access badge on April 21, 2016, and discovered that it was disabled. The access badge was not used again during 2016. Matt Weldy, a staff member in the district’s technology department, stated that he asked Ms. O’Nan why she was not using her access badge, and she replied that she didn’t want people to know where she was.

I requested from the district’s technology department access to data showing key access at Hilton Head Island High School’s front door, where entry might have been gained by using a key instead of an electronic access badge. Upon receiving and reviewing the information from a “Door Forced Open” report, I determined that an unknown person or persons had made entry numerous times using a key.

I reviewed a six-month period from 9-1-2015 through 2-29-2016 and concluded that there were 10 instances between Nov. 12, 2015 and Feb. 21, 2016 when the front door was opened and the alarm disabled between midnight and 4:27 a.m.

- Nov. 12, 2015, when the high school's front door was opened at 12:38 a.m. This was the night of Veterans Day, when the school had been closed.
- Nov. 29 at 1:40 a.m. (a Sunday morning).
- Dec. 2, 2015 at 3:20 a.m. (a Wednesday morning).
- Dec 17, 2015 at 1:40 a.m. (a Thursday morning).
- Dec. 19, 2015 at 1:14 a.m. (a Saturday morning).
- Dec. 21, 2015 at 2:05 a.m. (a Monday morning).
- Dec. 23, 2015 at 1:29 a.m. (a Wednesday morning).
- Dec. 27, 2015 at 2:49 a.m. (a Sunday morning). Hilton Head Island High School was on winter break from Dec. 18, 2015 thru Jan. 1, 2016.
- Jan. 17, 2016 at 3:16 a.m. (a Sunday morning).
- Feb. 21, 2016 at 12:24 a.m. (a Sunday morning).

I obtained from the district's technology department the e-mail history of Ms. O'Nan, including any communication she might have had with DeJuan Holmes, whose previous work e-mail address I obtained from BCSO. Upon receiving and reviewing the history, I determined that Mr. Holmes and Ms. O'Nan communicated by e-mail regularly between September 2015 and April 2016.

On Dec. 14, 2015, O'Nan emailed Staff Sgt. Holmes and said, "Final Exams here...too quiet and boring." Staff Sgt. Holmes responded at 10:43 a.m. "Make some changes excitement." O'Nan responded by stating, "In order to do that...you need to come here."

On Dec. 18, 2015 at 11:06 a.m. (a Friday during school hours), Ms. O'Nan e-mailed Staff Sgt. Holmes a picture that appeared to be from a tropical location and stated, "This is where we need to go.:)."

On Jan. 18, 2016, at 9:55 p.m., Ms. O'Nan e-mailed Staff Sgt. Holmes, "We have a drug search for Thursday morning....I think you need to find a reason to stop by." Then on Wednesday Jan. 20, 2016 at 10:08 p.m., Ms. O'Nan e-mailed Staff Sgt. Holmes: "We have a drug search tomorrow morning...you need to come by and hang out..."

I spoke with Lt. Brian Baird, Special Investigator for the Beaufort County Sheriff's Office (BCSO), in regard to any phone numbers used by Staff Sgt. Holmes in 2015 or 2016. Lt. Baird said Staff Sgt Holmes had used several BCSO phone numbers as well as a personal phone number listed as [REDACTED]. School district PowerSchool records for the 2015/2016 school year show that Staff Sgt Holmes listed his personal cell phone number at [REDACTED] (Staff Sgt. Holmes' contact information was maintained in PowerSchool because he was the parent of a student).

On January 23, 2019, I obtained from the district's technology department the call record for Ms. O'Nan's district-issued cell phone (843-441-7623) from August 24, 2015 through April 23, 2016. District records show that during this period, there were 338 phone calls made between Ms. O'Nan's district-issued phone and the personal cell phone of Staff Sgt. Holmes (165 outgoing calls from Ms. O'Nan to Staff Sgt. Holmes and 173 incoming calls from Staff Sgt. Holmes to Ms. O'Nan.)

On several dates, phone calls between those two phones corresponded to instances in which a key was used to enter the high school:

- At 3 a.m. on December 2, 2015, a call was made from Ms. O'Nan's number to Staff Sgt Holmes' number. At 3:20 a.m., a key was used to enter the high school.
- On December 19, 2015, a key was used to enter the high school at 1:14 a.m. A phone call was then made at 3:26 a.m. from Ms. O'Nan's number to Staff Sgt Holmes' number that lasted 2 minutes.
- On December 27, 2015 at 2:32 a.m., a call was made from Ms. O'Nan's number to Staff Sgt Holmes' number. A key was used to enter the high school at 2:49 a.m.
- On January 17, 2016 at 3 a.m., a call was made from Ms. O'Nan's number to Staff Sgt. Holmes' number. At 3:16 a.m., a key was used to enter the high school.

The January 17 phone call at 3 a.m. came after a number of communications the previous day between Ms. O'Nan and Staff Sgt. Holmes' e-mail addresses. Those conversations appear to focus on them meeting up later in the evening. Ms. O'Nan e-mailed that she couldn't meet until after 9, and Holmes replied "me too." They went back and forth discussing times of 1:30 and 1:15. Eventually, at 3:50 p.m., Staff Sgt. Holmes emailed O'Nan and said, "maybe at about 2/ or 3". O'Nan replied at 3:52 p.m. by stating, "I could get away at 3." Staff Sgt. Holmes responded "ok" and "ok ... Let's do that." Ms. O'Nan asked if Staff Sgt. Holmes was on call and he responded with "No but I'll sneak out late." Ms. O'Nan then emailed again at 10:06 p.m. and said "Hey...I'm trying to stay off the phone. Want me to call you at 3 and hang up? Staff Sgt. Holmes responded by saying "Yes...Can't text."

On January 17 at 3 a.m., a phone call was made from Ms. O'Nan's number to Staff Sgt Holmes' number. Then, at 3:16 a.m., according to district records, a key was used to enter the high school.

From August 24, 2015 through April 23, 2016, phone records show 94 phone calls made during school hours between Ms. O'Nan and Staff Sgt. Holmes. During the 2015-16 academic year, school hours for Hilton Head Island High were from 7:45 a.m. to 2:45 p.m.

The information I have received and reviewed during this investigation was available for review during the initial complaint back in 2016. Information that was available in 2016 and not available during my investigation included alarm information from Sonitrol and video footage from BCSD.

1. On May 4, 2016, Reference (A), was completed and submitted documenting the initiation of an Administrative Inquiry into allegations that Staff Sergeant (SSgt.) DeJuan Holmes was involved in an adulterous relationship with Mrs. Amanda O'Nan, who is married to the complainant, Mr. Chris O'Nan. During the conduct of the inquiry and prior to SSgt. Holmes being interviewed, he submitted his resignation from the sheriff's office. After SSgt. Holmes resigned the inquiry was stopped. On June 21, 2018, Mr. Holmes requested to be interviewed to bring full resolution to the Administrative Inquiry from 2016.

2. On June 21, 2018, I interviewed Mr. DeJuan Holmes at the BCSO Office. Prior to asking him any questions I provided him with a BCSO Office of Professional Responsibility (Subject) form. I advised him that even though he did not work at the sheriff's office any longer, he still had certain rights that pertain to Administrative Investigations and he said he understood those rights. Mr. Holmes read the form, stated he understood it and did not have any questions about it. He then initialed, signed and dated the form indicating the same. I reminded him of the allegations made by Mr. O'Nan and he said he was familiar with those allegations. I asked him to tell me what happened regarding that matter. Mr. Holmes said he did have a relationship with Mrs. O'Nan and that relationship had since ended. I asked him about driving Mrs. O'Nan around in his work vehicle and he said he did allow her to ride in his BCSO vehicle several times, and that he

was on duty working during those times. I asked him if he complied with the BCSO Policy to notify dispatch when you have a civilian passenger in the vehicle and he said he did not. I asked him about checking vehicle license plates through the BCSO Dispatch Center and he said there was one time he was going off duty and he parked by his house when he observed a vehicle pull up and park in front of a neighbor's house. He said he exited his BCSO Vehicle and noticed the other car turned its headlights off, but the engine was still running. He said he did not recognize the car, so he returned to his BCSO Vehicle and when he started it, the other car started to leave. Mr. Holmes said he followed the car and ran the license plate because he felt the car was suspicious due to it following him home at that time of night. He said the plate came back clear so he eventually stopped following it and returned to his home. I asked him if Mrs. O'Nan was in the BCSO vehicle with him and he said no, he said she was in the vehicle earlier in the night, but he dropped her off prior to going to his house. He said he did ask Mrs. O'Nan about it and told her the registered owner's name. He said Mrs. O'Nan said she knew the owner of the car as a family friend. I asked him about the nature of his relationship with Mrs. O'Nan and if it was a sexual relationship. He said yes it was. I asked him if he engaged in sexual activity with Mrs. O'Nan while he was in a paid on duty status with BCSO and he said yes he did. I asked him if he engaged in sexual activity with Mrs. O'Nan while on duty and inside the Hilton Head High School and he said yes he did. I advised him there were obvious violations of BCSO Policies and he said he did understand that and he was very sorry for his actions. He said he wanted to apologize to the Sheriff, BCSO, and his family. He said he regrets what he did, he hopes by coming in and admitting what he did that he will be able to move forward with his life and hopefully get back into law enforcement again, preferably with BCSO. The interview was recorded and saved to a CD. The OPR Warning form and CD are attached. (Exhibit # 1 and # 2)

Synopsis:

On April 27, 2016, Mr. Chris O'Nan, Ms. Karen Anderson and Ms. Lauren Martel submitted BCSO Complaint Forms alleging suspicious activity on Hilton Head. I interviewed Mr. O'Nan and he alleged SSgt. DeJuan Holmes has been involved in an adulterous relationship with Mrs. Amanda O'Nan, who is married to Mr. Chris O'Nan and is the Principal at Hilton Head High School. Mrs. Anderson alleged SSgt. Holmes followed her and ran her license plate for no official reason while Mrs. O'Nan was riding in his BCSO vehicle. On April 29, 2016, SSgt. Holmes submitted his resignation. Due to his resignation, the Administrative Inquiry was not closed at that time. On June 21, 2018, Mr. DeJuan Holmes was interviewed to bring resolution to the 2016 Administrative Inquiry. The original documents were submitted to the Office of the Sheriff for Beaufort County.

admitted he conducted a check of Mrs. Anderson's license plate because she followed him to his residence and parked across the street from his house around 2:00 am. He said he felt that was suspicious. He said he asked Mrs. O'Nan about the registered owner and she said she knew that lady. Mr. Holmes did admit that he allowed Mrs. O'Nan to ride around in his issued BCSO Vehicle while he was on-duty working without prior approval and did not notify anyone he had a passenger in the vehicle as required by policy. Mr. Holmes admitted that he did engage in sexual relations with Mrs. O'Nan while he was in a paid on duty status with BCSO and that some of the on duty sexual activity occurred within the Hilton Head High School, where Mrs. O'Nan was the Principal at the time.

General Order Review:

113A3 (Code of Conduct)

Policy:

All employees of the Beaufort County Sheriff's Office must be fully aware of the ethical responsibilities of their positions and must constantly strive to live up to the highest possible standards of professional policing. To that end, the Beaufort County Sheriff's Office has adopted a Code of Conduct as a guideline for all sworn deputies, civilians and auxiliaries. As employees of the Beaufort County Sheriff's Office we are held to a higher standard by the public and the community we serve and in the responsibilities we have sworn to uphold. Therefore, it is the policy of this agency that employees conduct themselves at all times in a manner that reflects the ethical standards consistent with the rules contained in this policy and otherwise disseminated by this agency.

Procedures:

A. General Rules and Regulations:

1. Obedience to Laws, Regulations and Orders:

a. All employees of the Sheriff's Office will not violate any law or agency policy, rule or procedure.

d. Employees will obey all lawful orders.

e. Employees will not engage in any conduct or activities on or off duty that reflect discredit on the Sheriff's Office or tend to bring this agency into disrepute, or impair efficient and effective operations.

f. Employees will cooperate fully in any internal investigation conducted by this agency or other authorized agency and will provide complete and accurate information in regard to any issue under investigation.

115A3 (Vehicle Assignments)

Policy:

The use of an assigned vehicle is a privilege and is not to be considered an automatic fringe benefit or right. This privilege is subject to revocation based on Deputy misconduct, misuse, or failure to comply with the regulations and policies set forth in this procedure.

Unmarked Vehicles: Deputy Sheriffs assigned to plain clothes details such as investigators, narcotics officers, victim's advocates and command staff officers as well as unmarked traffic enforcement officers are assigned vehicles of various makes and models that have no BCSO markings.

Procedure:

A. Vehicle Assignment Categories:

1. Exclusive Assignment/Limited Use:

a. All sworn certified law enforcement Deputy Sheriffs of the Sheriff's Office are assigned a vehicle of type and manufacture best suited for their particular job description and in the best interest of the efficient and effective performance of their duty assignment.

d. Deputy Sheriffs with these assigned vehicles must at all times be able to communicate with their immediate supervisor by either phone or radio. They are considered to be 24/7 employees, subject to immediate recall in the event of an emergency.

e. Deputy Sheriffs in the Exclusive Assignment Limited Use category will be permitted off-duty use of their assigned vehicle within restrictions and guidelines of the regulations and policies set forth within this procedure.

B. General Use:

1. This policy applies to all personnel who are assigned a Sheriff's Office vehicle. Some exceptions to this policy are permitted by the Sheriff due to the nature of the particular Deputy Sheriff's assignment and responsibilities, or as the Sheriff deems appropriate and in the best interest of the Sheriff's Office.

2. Law enforcement vehicles are assigned to law enforcement personnel on a permanent basis for official use only except as otherwise authorized herein.

3. Deputy Sheriffs are permitted to transport non-sworn citizens in their County vehicles while on and off duty. The Deputy Sheriff must be in uniform or professional civilian attire and travel will be limited to a minimum necessary or authorized herein. The Deputy Sheriff is prohibited from driving their assigned vehicle while dressed in shorts, tank tops, sandals, sweat pants or similar type clothing.



12. Deputy Sheriffs using their assigned marked vehicles while in an off-duty status are required to check in and out of service, monitor the radio at all times, and must advise the communications center when they are near any emergency call for law enforcement service. Deputy Sheriffs must carry their duty weapon, Sheriff's Office identification, and body armor while operating their vehicle off-duty. In the event a Deputy Sheriff observes a situation requiring law enforcement action, they must notify the communications center of the location and nature of the situation and shall take the appropriate action, remaining at the scene until the situation is resolved or until relieved by on-duty personnel.

Conclusion(s):


This Administrative Inquiry determined the allegations against former SSgt. DeJuan Holmes are substantiated for violations of BCSO General Orders for the Code of Conduct and Vehicle Assignments. Former SSgt. Holmes did allow a civilian to ride in his issued BCSO Vehicle without approval and for no official purposes while he was on duty and working on several occasions for extended periods of time. Additionally, former SSgt. Holmes admitted to engaging in sexual acts with a married woman while in a paid on duty status with BCSO. He did further admit that some of these on duty sexual encounters happened within the Hilton Head High School. These acts are in violation of the Code of Conduct.

The allegations are substantiated for violations of the BCSO General Order for Code of Conduct and Vehicle Assignments as referenced above in the General Order Review section.

You are ordered to keep this matter confidential and only discuss it with the assigned investigator or authorized person(s). You are specifically prohibited from contacting complainants or witnesses inside or outside the Sheriff's Office in any manner.

Should you have any questions regarding this allegation, Investigator lt. Baird has been assigned to this case.

Transcript of Interview:

Lt. Brian Baird of BCSD interviewing DeJuan Holmes

-Baird: "This is Lieutenant Brian Baird Beaufort County Sheriff's Office. It is currently 11:26 am on 6/21/2018. I'm here with DeJuan Holmes who is a former deputy with the Beaufort County Sheriff's Office in reference to an allegation that was made back in 2016 prior to, uh, Mr. Holmes' resignation from the Sheriff's office. Even though you're not an employee anymore we-we're still going to provide you with your rights for an administration investigation just so you understand what they are, okay? What I'd like you to do here is read through here when you get down to where it says 'acknowledgement'"

-Holmes: "Yes, sir"

-Baird: "Just let me know when you're there. Don't sign anything, just let me know when you're there."

-Long Pause-

-Holmes: "Okay."

-Baird: "Do you have any questions about anything?"

-Holmes: "No, no, n-no."

-Baird: "Do you understand everything?"

-Holmes: "Yes"

-Baird: "Okay. Go ahead and initial, sign, and date."

-Holmes: "The date is-"

-Baird: "-the twenty first. I-I know you're aware of the allegation and basically just to reiterate it, uh, Mr. O'Nan, his attorney, and another woman contacted the Sheriff's office back in 2016 and alleged that you and his wife were involved in an adulterous relationship and that the two of you had been...seen together on numerous occasions - he actually hired a private investigator to follow the two of you. He-uh-I never saw any videos. He claims he has videos of the two of you...uh...at the school, at a Westin hotel in Charleston, uh, he claims that you travelled to Las Vegas together -um- obviously, the incident in Charleston and the incident in Las Vegas and-if...if. There's anything that would be, uh, during your off-duty time-"

-Holmes: "No, sir"

-Baird: "That is a -uh- personal matter. Um- there's allegations that you were-uh-driving Miss. O'Nan around in your work vehicle, um, on and off duty. There's allegations that you were running license plates for unofficial purposes, and, obviously, the, um, allegation of, uh, adultery at the school and the question obviously there is you know - on and off duty type stuff. Can you tell me what's going on with everything there?"

-Holmes: "um...yes. We were friends. We had a relationship, um - um, I did run a tag that came to my house, one house that was getting in the car around 2 - - 2 O'clock - - 2:30 in the morning. I don't remember what date or time that was but what, what day it was but uh, exact time I do not know and um, the vehicle came to my house as I was pulling in, um, and then I turned, cranked my vehicle back up and went to shut it off. I thought it was kinda suspicious to have a vehicle following me to my house at that time know...knowing what type of job I was- -I did at

that time. I followed the vehicle out toward Bluffton and just like ran a tag—um—and it was a...I can't remember the name that came back on the tag. Um...and then the vehicle continued out toward 95 I turned around and 170? then came back, um, to—"

-Baird: "Who was in the car with you when you did that?"

-Holmes: "I was alone."

-Baird: "You were alone?"

-Holmes: "Yes."

-Baird: "-um...Mrs. O'Nan."

-Holmes: "I'm sorry?"

-Baird: "Mrs. O'Nan, uh, or...is that how you say it? O'Nan?"

-Holmes: "O'Nan."

-Baird: "O'Nan. um-she told people at the school...that she was with you and-uh-when, when you ran the tags."

-Holmes: "No. No."

-Baird: "Okay"

-Holmes: "No one was with me. Actually, I was going home for the night."

-Baird: "Um- but everything matches up except for that."

-Holmes: "Yes."

-Baird: "She said she was with you pulling in to Red Tip Lane and—"

-Holmes: "...uh...no. No. I remember that night, like I said...I remember because I was weirded out because um- I pulled up on the side of my fence...the backside of my fence where I normally kept my-my patrol vehicle. Uh. Um. And I thought it was weird because a car stopped in front of my neighbor's house and, like, that's weird. That's very weird. Ne-neighbor-...everybody's normally asleep that time of the night. So I cranked, turned my car off and-"

-Baird: "Okay"

-Holmes: "got the car to stop and it was just sitting there idling and I cranked my car back up and the lights came on and it backed up and-uh-went down my dirt road. To come to my house you have to be planning to come to my house because it's like making a horseshoe. I went back out and got behind the vehicle on 278 and got close enough until I could run it and then I just backed off to kinda see where it was going -uh-...it went out and I remember the car went across 170 on 278..um..and that's where I made a Ueey [U-turn] and came back up on 278 from 170 and head-headed back to my house and parked where I normally park."

-Baird: "Did you talk to Mrs. O'Nan about that?"

-Holmes: "I-I did tell her about it, yeah...uh-uh...it was kinda weird"

-Baird: "Did you ask if she knew the person?"

-Holmes: Uh-I did and she did say that she knew the person...um- I had seen her earlier...um...and I don't want to say...um.. but at times she was-she was not in my vehicle."

-Baird: "In reference, how many times did she actually ride around in the car with you?"

-Holmes: "I can't be exact...uh...if I had to give an estimate probably about 3 or 4 times."

-Baird: "Okay. How many times were you on duty when that was occurring?"

-Holmes: "...Eh...not to be exact...probably 3 or 4 times maybe...not to be exact really because I don't know exactly how many times."

-Baird: "Did you comply with our policies on no-notifying dispatch when you had a passenger in the car?"

-Holmes: "No, I didn't."

-Baird: "Well, what was the purpose of running the plate?"

-Holmes: "Because I thought it was suspicious Like I said, I've been -um- actually, sir, once before that -um- before any of this was going on I remember one morning leaving out my mom contacted me and said there's a car in the wooded part of where we lived and I got out and jumped in my patrol vehicle. I went back and I ran the tag-um-I went out with the vehicle-um-first and there was somebody in the car. Ran the tag and -um- I was-eventually I arrested the guy. Deputies came out and we arrested the guy 'cause he had warrants...actually he-I think he went...I ended up knowing the guy he just gotten out of prison. I arrested him and he had a kid in the car and everything. It was like 6 O'clock in the morning and another occasion years before that we found a stolen car back in the same area"

-Baird: "Okay"

-Holmes: "So I guess it's not uncommon to do that so"

-Baird: "Sure"

-Holmes: "And then being shot at back in '99...my suspicions have always been raised -um"

-Baird: "In reference to your relationship and her...according to the private investigator, he has video of the two of you in a sexual relationship inside the school...did-did you ever engage in anything like that inside the school?"

-Holmes: "...Yes"

-Baird: "Did you ever do it while you were on duty?"

-Holmes: "...Yes."

-Baird: "um. O-obviously with-there are some policy violations here..."

-Holmes: "Yes"

-Baird: "What I'm going to do is type this up um submit it through the chain up to the sheriff - um- I- I think this will finally bring resolution to this. It's been a couple years coming and uh-uh I assume you'll hear from one of the two of them or both of them...you-you have-have anything else you wanna tell me or anything else you wanna say or..."

-Holmes: "I just wanna say that you know on account of me, I know what I did was not proper, was not right. Um but I think that I've been going for some time I think I paid my dues um-um I didn't mean to bring any bad shame to the sheriff or my family definitely not myself but"

-Baird: "Sure."

-Holmes: "Things happen and I'm very sorry for um what I did um a mistake was made um and I'm-I'm sorry for the mistake I made and I've prayed and ask forgiveness for it and its time for me to move on from it even if it does not come back in the decision that I want I know that I feel better by talking about it"

-Baird: "Sure"

-Holmes: "I can walk out of here and...knowing that I have re...released this guilt this shame off my chest here"

-Baird: "Yeah. I know its not easy to talk about, but I appreciate you coming in and resolving this and getting it behind you like you said. The first step in moving forward is you know is getting all that behind you and moving forward. If you do not have anything else to say I'm going to go ahead and stop at this tape."

-Holmes: "No"

-Baird: "It is now 11:37 I'm going to stop the tape"

1. On April 27, 2016, Mr. Chris O'Nan, Ms. Karen Anderson and Ms. Lauren Martel completed the attached Beaufort County Sheriff's Office (BCSO), Complaint Forms. They met with Sheriff P. J. Tanner and alleged Staff Sergeant (SSgt.), DeJuan Holmes has been involved in an adulterous relationship with Mrs. Amanda O'Nan, who is married to Mr. Chris O'Nan. Sheriff P. J. Tanner then directed the initiation of this Administrative Inquiry.

2. On May 2, 2016, I received the BCSO Complaint Forms from Chief Deputy Michael M. Hatfield. (**Exhibits # 1, # 2, and # 3**)

3. On May 2, 2016, I contacted Mr. Chris O'Nan and requested to meet with him for an interview about his allegations. He requested to do the interview over the telephone. He said during October 2015, he became suspicious of the way his wife, Ms. Amanda O'Nan was acting. He described her behavior as that of a 17 year old girl always texting and on Facebook. He said she would receive a message and delete it before he could see it. He said he was able to see some of the messages and there was one from SSgt. DeJuan Holmes saying "got a juicy ass" and he said it also stated what SSgt. DeJuan Holmes wanted to get into his "juicy ass".

wife's ass. He said since then there have been hundreds of messages between them and he has hired a private investigator that has proof SSgt. Holmes and Mrs. O'Nan have been having an adulterous affair. He said Mrs. O'Nan's brothers are both aware of the affair as well. He said he has three children with Mrs. O'Nan and prior to this incident they have never had any marital problems. He further said during October 2015, Mrs. O'Nan told him she was feeling uncomfortable because a BCSO Officer named D. Homes was harassing her. He offered to speak to the man, but she said she would handle it professionally through official channels because she met him through work as she is the Principal of the Hilton Head High School and he is a deputy who was assisting with issues at the school. He said he eventually started to see more and more messages going back and forth between his wife and SSgt. Holmes and began to wonder what was going on. He said he asked some friends to follow his wife to see where she was going and on several occasions different people caught her meeting up with SSgt. Holmes at various locations to include the Hilton Head High School. He said she would receive a text message in the middle of the night and get up and leave, claiming there was a problem at the school. She was seen meeting SSgt. Holmes at the school and taking him into her office after midnight, where they would stay for over an hour at times. She once told him she had to attend a Principal's training event in Charleston, SC, and he discovered she actually went to stay overnight at the Westin Hotel on Hilton Head Island with SSgt. Holmes. She also bought two tickets to Las Vegas and he believes she took SSgt. Holmes to Las Vegas with her. He further states she removed a large sum of money from the family account and had a breast enhancement for SSgt. Holmes. He said SSgt. Holmes would contact her when he was getting off work late at night and she would leave the house and not return for hours, often taking him into the Hilton Head High School. He said he also knows he has taken her places in his issued BCSO Vehicle and he has run various license plates through dispatch, while his wife was with him, for no official police business reasons. He said on February 15, 2016, he argued with his wife about this relationship, he took her cellular telephone and threw it outside of the house. He said when she found the phone she called BCSO and he was arrested for Domestic Violence even though he never used any physical violence against her. Mr. O'Nan's arrest is documented in BCSO Incident Report # 16S036402. He said he has witnesses and he has a private investigator that has obtained proof of his wife having a physical relationship with SSgt. Holmes inside her office in the Hilton Head High School. The Interview was recorded and saved to a CD. The BCSO Complaint Form and CD are attached (Exhibits 1 and 2) and are

4. On May 2, 2016, I interviewed Ms. Karen Anderson regarding the BCSO Complaint Form she submitted. She said she has been friends with Mr. O'Nan for a long time. She said she has children that have attended Hilton Head High School, where Mrs. O'Nan is the Principal. She states she has witnessed Mrs. O'Nan and a black man, she later learned was a BCSO Deputy Sheriff named D. Holmes riding together in his BCSO vehicle. She said she told Mr. O'Nan about seeing them together in the deputy's work vehicle near the Poseidon Restaurant. She said one time Mr. O'Nan asked her to go to Red Tip Lane to see if Mrs. O'Nan's car was at SSgt. Holmes' house. She said as she was nearing Red Tip Lane she observed SSgt. Holmes pulling up in his black work vehicle and when she turned away he began to follow her. She said she was later told by teachers at the school that Mrs. O'Nan told them she was in SSgt. Holmes' work vehicle when they followed her and Mrs. O'Nan listened to him check her license plate over the police radio. She said she is very worried now that SSgt. Holmes knows her name and address from her license plate. I advised her I would look into this matter and contact her if I needed more information. The interview was recorded and saved to a CD. The BCSO Complaint Form and CD are attached. (Exhibit # 2 and # 6)

5. On May 2, 2016, I spoke with Mrs. Lauren Martel and she advised she is Mr. O'Nan's attorney for his Family Court proceedings. She said she did not have any firsthand knowledge of Mr. O'Nan's allegations. She said she will be handling this matter in court when it comes to that. The contact was recorded and saved to a CD. The BCSO Complaint Form and Cd are attached. (Exhibit # 3 and # 6)

6. On May 2, 2016, I attempted to contact Mr. Rich Ulbrich, Private Investigator, at Mr. O'Nan's request. I left him a voicemail and have not heard back from him. The call was recorded and saved to a CD. The CD is attached. (Exhibit # 6)

7. On May 2, 2016, I informed Chief Deputy Michael M. Hatfield of the allegations and he informed me SSgt. DeJuan Holmes resigned from the sheriff's office. The resignation letter is attached. (Exhibit # 5)

8. On May 3, 2016, I left a voicemail message for Mr. O'Nan advising him that SSgt. Holmes resigned and therefore, this Administrative Inquiry would be closed. The call was recorded and saved to a CD. The CD is attached. (Exhibit # 6)

9. On May 3, 2016, I E-Mailed Ms. Martel and advised her that due to SSgt. Holmes resignation this Administrative Inquiry would be closed. She stated and I E-Mailed her with a Freedom of Information Act Request to find out and copy to file with the Office of Sheriff for Beaufort County. (Exhibit # 7)

10. Subsequent to receiving Ms. Martel's FOIA Request I contacted Lt. Jimmy Walton, BCSO's Cellular Telephone Coordinator. He reported SSgt. Holmes' cellular telephone was taken from him when he resigned and per the standard BCSO Policy he notified Verizon Cellular to disconnect the service for this telephone. He said he was notified on May 3, 2016, the service was completed. He further reported Chief Deputy Michael M. Hatfield had the telephone, searched the history and was unable to locate Mrs. O'Nan's telephone number in the history prior to disconnecting the service. (Exhibit # 8)

Synopsis:

On April 27, 2016, Mr. Chris O'Nan, Ms. Karen Anderson and Ms. Lauren Martel submitted BCSO Complaint Forms alleging suspicious activity on Hilton Head. I interviewed Mr. O'Nan and he alleged SSgt. DeJuan Holmes has been involved in an adulterous relationship with Mrs. Amanda O'Nan, who is married to Mr. Chris O'Nan and is the Principal at Hilton Head High School. He said he has proof of them meeting after midnight at the school and spending hours together inside her office in Hilton Head High School. He further said he hired a private investigator that has collected proof of his allegations. I interviewed Ms. Anderson and she alleged various teachers at Hilton Head High School told her SSgt. Holmes followed her and ran her license plate for no official reason while Mrs. O'Nan was riding in his BCSO vehicle. I spoke with Mrs. Martel and she advised she is Mr. O'Nan's Family Court Lawyer and she did not have any firsthand knowledge. When SSgt. Holmes was advised of these allegations, he immediately submitted his resignation and declined to be interviewed. Due to his resignation, this Administrative Inquiry will be closed.

Conclusion(s):

This Administrative Inquiry was initiated into allegations that SSgt. Holmes was involved in an adulterous relationship with Mrs. Amanda O'Nan, the Principal at Hilton Head High School and that SSgt. Holmes ran various license plates through the BCSO Dispatch Center without any official law enforcement purpose while Mrs. O'Nan was riding in his BCSO Vehicle. During the onset of this Administrative Inquiry and prior to being able to officially interview SSgt. Holmes, he submitted his resignation from BCSO effective immediately. Due to the resignation, this Administrative Inquiry is closed.

Thank for your message, but I believe the parties have already worked out (through Molly) that Chris will see the twins from 10:30 to 5 on Sat, and noon to 5 on Sunday. Amanda's mother will deliver them for this visit. I wholly disagree with your accusation that Amanda has "withheld visitation." To the contrary, this past weekend her mother went out of her way to meet your client to bring the children and to give him a car to use, and he called at the last minute (after she'd already travelled to the south end of HHI) and cancelled.

On another note, I'm concerned your client's continued harassment and recent "stalking" behavior of my client. Last weekend Amanda took steps to verify her suspicions that she was being followed and stalked, and her suspicions were true. On Friday night when she went for a birthday dinner with a large group of friends, she has personal knowledge that Chris's friend (Karen Anderson) sat outside the restaurant at least until 1:15 a.m. watching for her. (She had left long before then but left her car there to determine if she was being watched). On Saturday, she went to the bar/restaurant at the Westin with several other adult chaperones after the HS prom. Again, she deliberately left her car in the parking garage all night and throughout the following day, and she has personal knowledge that Chris and Ms. Anderson drove by her car at least 3 times, sometimes stopping (presumably to take pictures). Days later, she was at the Buckwalter theater plaza, and Karen Anderson was tracing through the parking lot apparently searching for something (presumably Amanda). This behavior has to stop. Although I hate to make this matter even more contentious than it already is, I will be forced to continue a contempt motion if your client continues to disregard the Temporary Order. Please provide the specifics of your client's car (who has it and is making the payments), as well as any documentation to support this. It's my understanding that he's told people it's been sold. This is my client's property and Amanda is entitled to know the specifics about this issue.
