RE: School District's Millage Surcharge Request

Dear Chairman Rodman:

The FY2018-2019 projected tax revenue for the Beaufort County School District was \$143,707,242. This amount was based on a 104.6 mill tax adjustment from the previous FY2017-2018 millage rate of 113.5. This 8.9 mill tax decrease was determined by a projected tax revenue increase due to a reassessment scheduled that fiscal year. This millage adjustment was expected to be revenue neutral. However, current estimates of FY2018-2019 School District revenue from ad valorem tax is \$134,937,820. This estimate will give the School District a revenue shortfall of \$8,769,820. When the projected revenue shortage was first identified in March 2019, the School District initiated austerity measures to cope with the projected shortfall. These measures were insufficient to completely offset the revenue shortage. Consequently, the District was forced to use fund balance in the amount of \$5,019,829.

This is the third time the millage decrease initiated during a reassessment year fell short of the goal of achieving revenue neutrality. During reassessment ten years ago, the School District absorbed a \$5million budget shortfall. Five years ago, during reassessment, the School District had a revenue shortage of \$5.2 million. In the last ten years, County ad valorem tax revenue shortfall has now totaled approximately \$19,406,622. This long-term revenue shortage has significantly depleted BCSD reserves. The resulting fund balance decrease this year moved our fund balance percentage of annual general fund spending from 14.7% to 13.6%. School Board policy establishes a target range of 15% to 17% of the next year's anticipated expenditures. Therefore, our current fund balance does not meet Board policy or accepted fiscal government finance practice.

Beaufort County School District recently received its bond rating from Moody's Investor Service. We were fortunate to maintain our Aa1 credit rating. The concern expressed by the Moody representative, during the interview before the rating was assigned, was our declining fund balance percentage. When compared to peer School Districts with an Aa1 rating, we fell short of the average fund balance for those comparable institutions. During the discussion, Moody's was informed that we were working with our County Council on a fund balance restoration plan that involved a millage surcharge. If that surcharge is not approved, the District's future credit rating could be at risk.

On May 16, 2019 at a Special Called School Board meeting, the Board of Education made and approved a motion directing, "The Superintendent to take all necessary steps to explore all legal channels to recoup the (then estimated) \$7.7 million lost to the District due to an error in the County's calculation of last year's millage rollback." Legal channels include a State Statute that allows a millage surcharge be assessed to deal with tax revenue shortfalls. The proposed millage surcharge requested by the School District can recoup the revenue lost and allow the District to attain its fund balance policy target.

Like Beaufort County, the School District's fund balance is our reserve to cope with the unexpected. The Beaufort County School District must be able to deal with the aftermath of a major catastrophic event just like the County. We must be able get children back into school as soon as possible and must have the fiscal liquidity to do so. We are confident that the Beaufort County Board of Education and the Beaufort County Council will work together to obtain the resources the School District needs to provide high quality education of the 22,000+ students enrolled in our public schools. We look forward to working with you to achieve this objective in the best educational interests of our students.
