Dear Ms. Spearman and Mr. Brenan:

Pursuant to State Board of Education Regulation 43-58.1, I am reporting that, on or about June 2, 2016, James C. Olsen, Coosa Elementary School ("CES") fifth grade teacher, resigned from employment with the Beaufort County District ("BCSD"). I had begun investigating Mr. Olsen, and he resigned rather than undergo further investigation for potential inappropriate contact with female students. Prior to resignation Mr. Olsen admitted his failure to follow a directive from his Principal and to being dishonest with his Principal and with me during the opening stages of the investigation.

In December, 2015, Charles DelForge, CES Principal, verbally directed Mr. Olsen to cease allowing female students to sit on his lap during class. Melissa Pender, CES fifth grade teacher, witnessed Mr. Olsen engaged in such activity and reported it to Mr. DelForge. Mr. DelForge subsequently witnessed the same activity, which lead to his directive. In May, 2016, Ms. Pender again observed Mr. Olsen allowing a female student to sit on his lap. She reported the same to Mr. DelForge. Mr. DelForge confronted Mr. Olsen, who admitted to such conduct. Mr. Olsen also admitted such conduct to me during a May 27, 2016 meeting.

Mr. Olsen was also dishonest with both his principal and me. His confession regarding dishonesty is set forth in the attached May 31, 2016, e-mail to Alice Walton, BCSD Chief Human Resources Officer.

Mr. DelForge reported this conduct to law enforcement as a potential issue regarding abuse of students. It is my understanding the Beaufort County Sheriff's Department is investigating Mr. DelForge's report regarding Mr. Olsen and is interviewing students possible affected.

This has been eating at me since last Monday night when I lied to Mr. DelForge. I also continued the lie on Friday. I was just trying to bluff my way through it. Stupid decisions. After your comment about thinking on Friday I was up front and honest I sat in my car and about cried. I can't continue to lie about it.

I have never killed anyone. Never been in combat, always in wrong unit or base. I made that up on the spot with Mr. DelForge to add credibility to my statement of how important the kid is to me. Stupid thought process. Then I tried to bluff it through with you and Dr. Moss on Friday. Your comment busted me. It would have come out with the Dr. anyway and I would rather you hear it from me than her. I have already been in to Mr. DelForge and confessed to him.

I will go to the Dr. and convince her I am not a threat to children or a consistent liar. I was distraught and devastated during the conversation with Mr. DelForge, is the only thing I can say, but that is still no excuse. I believe in the honor I spoke about on Friday, but I was not honorable with this and will I have to live with it. It will haunt me for a long time regardless of the outcome of the Dr. evaluation. It was a stupid, bad

decision and I apologize to you and Dr. Moss. I can only say I screwed up and ask your forgiveness.

I would have come back to tell you this in person, but I am too ashamed and embarrassed and I know you are very busy.
