Board of Education Summary - November 20, 2012

Board Chairman Fred S. Washington, Jr. called the meeting to order at 6:12 PM.

Mrs. Bush moved to approve the Intergovernmental Agreement relating to the New River Tax Increment Financing District between Beaufort County and the School District of Beaufort County, reviewed with the Board in executive session, and to amend the District's 2012-2013 Budget to conform to the agreement. The motion passed.

School Report Card

South Carolina School Report Cards are in, and the Beaufort County School District continues on its path to significant improvement and achievement.

- Improved student achievement and increased on-time high school graduation rates led to higher ratings for Beaufort County schools on 2012 School Report Cards released recently by the South Carolina Department of Education.
- The total number of Beaufort County schools with Absolute ratings of Good or Excellent increased from 14 in 2011 to 22 in 2012.
- The number of district schools rated Good or Excellent has increased from seven in 2009 to 22 in 2012 (25 percent to 71 percent).
- The number of schools rated Average, Good or Excellent has increased from 21 in 2009 to 29 in 2012 (75 percent to 94 percent). The district uses 2009 as the base year for longer-term comparisons because South Carolina adopted a new statewide testing system (PASS) for all students in grades 3-8.

Board Business Action

Board made a motion to approve Calendar Option No. 2 (school year ending in June). Dr. Rosswurm shared survey results from parents and the public. Twenty-one percent selected Calendar 1 and 79 percent selected Calendar 2. The Board voted 9-1 in favor of Calendar 2.

Board Comment

Mr. Evans reported on bullying presentations made at several schools in Beaufort County and commended the students and teachers.

Superintendent's Report

Dr. Melissa Sheppard reported on Extended Learning Time and reviewed four years of progress since its inception in 2008-2009. Last year, achievement gaps in math were not as significantly changed by ELT as in other years, while reading gaps were improved in all grades except Kindergarten and 1.

Dr. Dereck Rhoads reviewed annual student achievement for MAP, HSAP, College Admissions, Advanced Courses and AP. MAP (K-8) testing showed that in math, students were above the national norm at all grade levels. In reading, students were above the norm in all grades but Grade 2. The percent passing HSAP on the first attempt has jumped from 74.1 in 2010 to 81.4 in 2012 and is above the state norm. College admission tests saw a slight decrease in both the SAT and ACT over last year. In AP tests, the number scoring 3 or better is down slightly, but the percentage of students passing has gone from 48 percent to 50.1%.

The Board requested that future reports indicate longitudinal growth.

Mrs. White presented the Quarterly Financial Reports. A copy of the unaudited 1st Quarter FY13 Financial Summary is posted on the district website: Departments/Finance/Accounting.

Mr. McCord reported on the bus camera installation. Currently we have 60 regular buses and five activity buses installed. The RSMS, BHS and Mink Point lots are completed. They will start next week at SHES and should be finished with North of the Broad schools by December 3. The projected finish date is December 21, 2012.

Chairman's Comments

Mr. Washington commented on the recent Board work sessions and how valuable it was to have the newly elected members of the Board in attendance.
