Jasmine is a student in Mr. John Cullinen's Photography 1 class. Students at the **Hilton Head Island School for the Creative Arts** recently created and dedicated a "Wall of Rememberance" for the Holocaust. The "Wall" was a multi-disciplinary project that began with the study of the Holocaust followed by the creation of a memorial dedicated to those who perished. With the assistance of community partner, The Arts Center of Coastal Carolina, students made ceramic tiles depicting scenes and symbols of the Holocaust. Once again, our students performed to rave reviews. Being invited to perform at the Spoleto Festival is a very, very big honor. We are so very proud of our students!
