- Mrs. Marion Coleman, Mrs. Tena Graber and Mr. Garner Jones received the Teachers Hall of Fame Award, which is presented to teachers with 10 or more years of service to Adult Education.

# **Public Comment**

A community member asked that Mary Cordray recuse herself from discussions about, and any votes on, a sales tax proposal related to USCB, where she is currently employed.

A community member spoke about the Board's conflict of interest policy.

A community member endorsed the Board's creation of a subcommittee tasked with aligning Board procedures with Robert's Rules of Order, and he encouraged the Board to establish guidelines promoting respectful exchanges of ideas.

# **Comment corrections**

Chair Cordray said that the Board had not begun discussions about an education sales tax. She said that she would participate in the sales tax discussion and vote and had already planned to excuse herself from possible discussions related to USCB.

Ms. Cordray said that Board members of the Board were aware of information distributed by a local organization and by news media that inaccurately portrays our educators. She said that Board members would be active in correcting misleading or inaccurate information.

Bill Payne suggested that members of the community obtain a copy of the district's 2016 Community Report for accurate information about the Beaufort County School District. He commended the district's educators for their work.

Mr. Campbell said that he feels it is a disservice to our teachers, students and parents to say that our students are not college or career ready.

Ms. Orischak commented that the CARE organization is focused on matters pertaining to the Board and the superintendent.

## **Chair's Report**

Ms. Cordray said there are special Board meetings scheduled for March 3 and March 4, and there is a need to schedule a meeting concerning the ACE Ad Hoc team that met with representatives from Jasper County.

Dr. Moss asked for authorization to send out FAQs on the education sales tax proposal to all School Improvement Council and Board members prior to the March 3 Board-SIC meeting. Ms. Cordray approved.

## **Committee Reports**

ACE – The committee met February 25 for a presentation of a fiscal year draft budget and a presentation by Jerry Henderson on potential programs and restructuring plan for ACE. The next meeting is March 17 at ACE.

Legislative – The committee does not have a meeting scheduled. There are Board members who will be attending the National School Board Conference in Boston April 9-11. Other upcoming conferences are the Advocacy Institute, June 12-14 in Washington, and the School Safety Conference in Orlando, July 25-29.

Curriculum and Instruction – The committee will meet on March 8.

Finance and Operations – The committee will meet March 10 at 4:30 p.m. at the DESC. Review of administrative regulations, construction update, Lady's Island Middle art studio project and e-rate approval.

Human Resources – Committee will not meet Thursday. Joseph Dunkle asked that the committee change to an Ad Hoc committee and meet only when there are items for the HR committee to consider.

Student Services – The committee met February 23 and discussed assignment of students, administrative regulations, and a plan to send a survey to parents about future graduation schedules. The committee's next meeting will be held on March 22.

#### Superintendent's Report

Dr. Moss announced the Palmetto Gold and Silver Award winners (20 district schools earned either Gold or Silver awards). He took questions from the Board.

Testing update: Dr. Moss gave an update on test data that presented national points of comparison for BCSD students (SAT, ACT, WorkKeys and MAP). He took questions from the Board.

Update on administrative regulations: Dr. Moss gave brief overview of changes and took questions from the Board.

Gifted and Talented update: Carmen Dillard, director of elementary education, provided the Board with information on gifted and talented program and took questions.

Chief Instructional Services Officer. Derek Rhoads presented the testing calendar for the spring semester and took questions from the Board.

## **New Business**
