Chairman's Report

Chair Mary Cordray said that the Board will set the agenda for the first January Board meeting on Monday, December 14, at 4 p.m.

Committee Reports

ACE – The committee has not met recently and normally doesn't meet in November or December. The Jasper County School board had taken no action regarding ACE.

Legislative Advocacy – The committee attended the SCSBA Legislative Conference on Hilton Head, and Mr. Campbell discussed some agenda items from that meeting. The committee met yesterday.

Curriculum and Instruction – The committee met and discussed PE 1.1 and 1.10. The next meeting will be in January.

Finance and Operations – The committee met December 8 to receive the annual financial report for the district. General consent to accept the report. The next meeting will be held January 11 at 4:30 p.m. at the DESC to discuss revised operational services and administrative regulations review. Will discuss PE 8 monitoring, review of CIP plan and enrollment projections, and gas utility easement approval.

Human Resources – The committee met last December 3 and discussed language for an ethics policy. The next meeting will be January 7 at 4:30 p.m.

Student Services – The committee has not met since its last meeting. The next meeting will be December 15 at 4:30 p.m. at Beaufort High.

Ms. Cordray announced that the Hilton Head Board members will host a town hall meeting at Palmetto Electric on December 15 at 6 p.m.

Superintendent's Report

Dr. Moss presented the Board with information on the federal ESSA legislation, a revision of the No Child Left Behind Act. ESSA passed the House and is expected to pass the Senate next week.

Dr. Moss announced that half of the \$1,000 locality supplement for employees would be distributed on Friday.

Affordable Housing Presentation by Bluffton High School students of Justin Robinson's Civil Engineering and Architecture class. The students presented a research report indicating that the county's cost of living is higher than other counties in South Carolina that compete with Beaufort County for teachers. The students presented the Board with preliminary designs for one-, two- and three-bedroom homes for teachers.

Dr. Rhoads presented the Board with achievement gap data. He discussed the "Zap the Gap" goals for our district. Laura Bush said that it is time for a call to action, called the data alarming and requested a plan from staff to improve academic achievement for minority students and reduce achievement gaps. Dr. Moss answered Board members' questions and listened to their suggestions.

Board Business Action

Motion to move remaining agenda items to after Board members' discussions with School Improvement Council members.

Phyllis White introduced representatives of the auditing firm of Eliott Davis Decosimo who presented the district's annual audit results. The Charleston-based auditing firm told the Board that its four-person team had found no weaknesses or deficiencies in the school district's internal financial controls during the 2014-15 fiscal year and no findings of noncompliance with state or federal laws. Motion to approve the audit. Approved.

The Board met with School Improvement Council members to discuss a range of topics that included the locality supplement, teacher turn-over rates and substitute teachers. Board members reported on the feedback they received from SIC members.

Motion to extend the meeting to 8:50. Motion approved.

General Obligation Advanced Refunding Bond: Motion to authorize the issuance of a general obligation advanced refunding bond not to exceed \$35 million.

Motion to authorize the submission of applications for E-rate category 1 services for E-rate funding year 2016. Motion approved.

Motion to approve PE 1.1 Annual Student Achievement report. Approved.

Motion to approve PE 1.10 Instructional Time. Approved.

Motion to approve the consent agenda. Approved.

Motion to accept a diversity statement and goals, second reading. Approved.

General Counsel Drew Davis presented the Board with changes to BCR7, then took questions. Motion to hold second reading during a January Board meeting. Approved.

Motion to extend the meeting until 9 p.m. Approved.

Mr. Davis presented the Board with the first reading of BCR16, Conflicts of Interest. Ms. Cordray said that she and Joseph Dunkle were not prepared to make a recommendation for the conflict of interest policy's nepotism wording. Motion to defer first reading of BCR16 to January. Approved.

Motion to adjourn. Approved.
