Chief Financial and Operations Officer Tonya Crosby provided an update on the 2017-2018 budget. Motion to approve and recertify the FY 2017-2018 General Fund Budget in the amount of \$225,764,555 to fund school operations. Ms. Crosby addressed the Board's questions. Motion approved.

Mr. Davis presented a quit-claim deed to the Town of Port Royal. Motion to approve the quit-claim deed to the Town of Port Royal. Motion approved.

Motion to approve a donation from the Hilton Head Island School for the Creative Arts PTO in the amount of \$20,000 to add to funds for a planned playground upgrade. Motion approved.

Mr. Davis presented changes to Policy 2.4. Motion to remove Section 8C. Motion approved. Motion to amend and add "Comment Corrections" to follow "Public Comments" under Section

D. Motion failed. Motion to remove section 9 on page 5 failed. Motion to approve Policy 2.4 School Board Meetings, Second Reading as amended to remove Section 8C. Motion approved.

Mr. Davis presented changes to Policy 3.2. Motion to approve Policy 3.2 Board Committee, Second Reading. Motion to amend to strike the portion of Section 8. Motion failed. Motion to amend and remove Section 8 in its entirety. Motion failed. Original motion approved.

Mr. Davis presented changes to Policy 4.1. Motion to approve Policy 4.1 Public Comment at Board of Education Meetings, Second Reading. Motion to strike the revision on page 2, section G. Motion passed. Motion to strike "the removal of participant from the board or committee room and BCSD grounds by law enforcement" on page 3, Article 4B. Motion failed. Motion to approve Policy 4.1 Public Comment at Board of Education Meetings, Second Reading with amendment. Motion passed.

Motion to appoint Board member Joseph Dunkle as Parliamentarian. Motion to table the matter until the chair is present. Motion failed. Original motion passed.

Consent Agenda

Motion to approve consent agenda. Motion approved.

Public Comments

A community member added to his comments from the first Public Comment section about Board actions. A community member congratulated the Board on its decision to use a Board member as Parliamentarian rather than hire one. A community member addressed Dr. Moss' comments on financial transparency and a financial audit. A community member commented on Board members' behavior toward one another. A community member distributed material that he said described school board corruption and talked about the need for a forensic audit. A community member spoke about the Board's public comment process and the firing of bus drivers.

Motion to adjourn approved. Meeting adjourned at 9:46 p.m.
