#### Showcase

Academic Improvement Officer, Dr. Melissa Sheppard, gave a report on the Extended Learning Time (ELT) Programs including Chinese Exploratory throughout the district and an overview of what is to come for ELT in the future. ELT served 36,734 students in grades K-10. ELT provided regular English Language Arts (ELA) and Math programming with an emphasis on support sessions in ELA and Math, English I and Algebra I, and HSAP test preparation. Special cultural and artistic opportunities were offered for the students in the Chinese Immersion program at BRES and HHIBE. The students worked on Chinese lettering/writing, story-telling as well as Chinese art and sculpture.
