Board of Education Summary February 15, 2011 School Board Meeting

Chairman Fred Washington called the meeting to order at 6:00 P.M.

Secretary Laura Bush made a motion to accept the recommendation of the Superintendent for the suspension from employment and conditionally accept the recommendation for the termination of employment of an individual who holds Continuing Contract teacher rights, Employee A. Subject to the Board's duty to review the matter on the merits pursuant to state law should the individual request a hearing. Motion passed.

Chairman Fred Washington called for the approval of the agenda.

Board Member Earl Campbell made a motion to approve the agenda. Laura Bush made a motion to amend the motion adding a donation to the agenda. Motion passed.

Secretary Laura Bush made a motion to accept the donation of \$2,500 from the Children's Relief Fund for 8 touch screen monitors for Hilton head Island Elementary School for the Creative Arts. Motion passed.

Hilton Head Island High School Junior, Jasmyn Howell, has been named a Distinguished Finalist for the Prudential Spirit of Community Award. Jasmyn is one of six students in South Carolina selected for this honor. Every year, the top high school and middle level youth volunteers in each state and the District of Columbia are selected as State Honourees by Prudential for this award. Each receives a \$1,000 award, an engraved silver medallion, and an all-expense-paid trip to Washington, D.C., for several days of national recognition events. In addition, two to 10 runners-up in each state are named Distinguished Finalists and receive a bronze medallion.

Hilton Head Island High School's Jessica Smith, Badlyn Rolfe, Miles Helman, and Michael Richards received honors at the recent SC High School Photography Competition at Winthrop University. Miles and Michael were finalists among the 280 entries from across the state.

Jessica Smith came in first place for her entry- *Only One* – which garnered a \$250 prize. Badlyn Rolfe - *I am the End of the World* – came in 3rd Place – and received a \$50 cash prize with the honor of having his print purchased for Winthrop's permanent art collection. This is Badlyn's second award this year as he is also the recent recipient of an Honorable Mention from the Regional Scholastics Art & Writing Awards.

In the Drug Abuse category, the school winner was Aaliyah Webb. The second and third place council winners were Mara Llorente and Julie Kautler. The school winners in the Alcohol Abuse category were Alina Flores and Destiny Guinan. Congratulations to these students!

One hundred nineteen Middle School eighth grade students were honored at the annual **Junior Scholars Honors Banquet** last week at Hilton Head Middle School. The South Carolina Junior Scholars Program was developed by the State Department of Education during the 1985-86 school year to identify eighth-grade students with exceptional academic talent and to determine strategies for their inclusion in special programs. In order to receive this honor, students must have scored advanced or proficient in English language arts and mathematics on the Palmetto Achievement Challenge Test (PACT) in the seventh grade.

Emily Wilbourne, a fifth grade student at **Hilton Head Island Elementary IB School**, is the winner of the Foundation for Educational Excellence's recent poster contest. Her drawing will be used on the poster announcing the upcoming Foundation Fundraiser, "Celebrate Inspiration." The event will be held Friday, April 29th at the Mall at Shelter Cove to raise money for Teacher Innovative Mini-Grants.

Our students are very giving. I learned this morning at our Student Advisory Council meeting that students at **Beaufort High School** have raised over \$20,000 for various charity causes this year. Wow! Congratulations to these students!

We agree to fund all of our current schools at a level to at least remain operational, in their current buildings, in the upcoming budget year.

Secretary Laura Bush made a motion to table the motion until the Board work session this coming Friday, February 18, 2011. Motion failed.

Final Motion: We agree to fund all of our current schools to a level to at least remain operational in their current building in the upcoming budget year. Motion passed.
