Chair Christina Gwozdz called the meeting to order at 6:28 p.m.

Coming out of executive session, motion that the Board designate attorney Rob Tyson to serve as the Board's Hearing Officer for the 2018-19 school year consistent with Regulation HRS-33 (approved). Motion that the Board make an offer to LS3P Associates for additional projects at May River High School and River Ridge Academy as recommended by the selection committee (approved). Points of Celebration

Parker's "Fueling the Community" Donation

Each year we receive a significant donation from Parker's convenience stores as part of the company's "Fueling the Community" promotion. The promotion gives one cent of every gallon of gas sold on the first Wednesday of each month to local schools. Some of the donation comes to the district office to support the school district's annual "Support Person of the Year" recognition program, which honors school nurses, social workers, bookkeepers, office managers, teacher assistants, school secretaries, and technology and data specialists. Money also is distributed to specific schools designated by Parker's customers when they purchase their gasoline. Tonight Parker's was recognized for their ongoing support of our staff and students. President and CEO Greg Parker was presented with a certificate.

Character Education Student of the Month – Nevaeh Duncan, fifth-grader at M.C. Riley Elementary

Our Character Education program was formed to support parents' efforts to develop good character in their children. Tonight we're celebrating the Character Ed Student of the Month exhibiting the Character Trait of "Honesty/Integrity." "Honesty" is defined as telling the truth, admitting wrongdoing. "Integrity" is defined as a firm adherence to a code of especially moral or artistic values. We were happy to announce that our Character Education Student of the Month for February was from M.C. Riley Elementary School. Principal Adrienne Sutton introduced her student.

National Merit Finalists - Pierce Daly and Meaghan Lyons, Hilton Head Island High School; and Faith Shupard, May River High School

About 1.6 million students from more than 22,000 American high schools initially entered the National Merit Scholarship Program competition by taking the Preliminary SAT/National Merit Scholarship Qualifying Test. About 15,000 students were eventually selected as finalists. To advance to the final round of competition, the semifinalists and their high schools had to submit detailed applications that provided information about academic records, participation in

school and community activities, leadership abilities, honors and awards. In addition, each semifinalist had to be endorsed and recommended by an official from his or her high school, write an essay and earn SAT scores that confirmed the student's earlier score on the qualifying test. We were happy to have two National Merit Finalist with us here tonight. First, IB Diploma Coordinator Mary Beth White introduced her students, followed by May River High Principal Joseph Bornscheuer introducing his student.

Guidance Counselor of the Year – Carrie Carter, May River High School

School counselors are vital members of the educational team. They help students with academic achievement, personal and social development, and career development, helping to ensure that today's students become tomorrow's productive and well-adjusted adults. Commended tonight were the district's Middle School Counselor of the Year, Gina Jacobs from Bluffton Middle, and Elementary School Counselor of the Year Nicole Bossak from Coosa Elementary. May River High School Principal Joseph Bornscheuer introduced 2019 Beaufort County School District School Counselor of the Year Carrie Carter.
