# **Superintendent's Board Meeting Summary: February 5, 2019**

Chair Christina Gwozdz called the meeting to order at 6:00 p.m.

Coming out of executive session, motion to approve Superintendent's recommendations for employment listed on the January 1, 2019 to January 31, 2019 Personnel Ratification Report (approved). Motion to approve the Superintendent's recommendations for the monthly Adult Education/Home School report for February, 2019 (approved). Motion in accordance with S.C. Code of Laws 59-29-80, that Student A be exempt from physical education requirements on the grounds that participation would jeopardize the student's health and well-being (approved).

Motion to approve the agenda as presented. Board member Cathy Robine wanted to add (to the Announcements section of the agenda) that this is School Counselor Week, and also that there is a rally for education reform scheduled to take place in Charleston. Board member Earl Campbell wanted to add information about the Charleston rally. Board discussion. Motion to approve the agenda with the addition of the three announcements and moving the Motion for Contingency Construction Funding Mechanism for River Ridge Academy Additions to the beginning of Board Business. (approved).

Our Character Education program was formed to support parents' efforts to develop good character in their children. Tonight we celebrated three Character Ed Students of the Month who exhibit the Character Traits of "Courage/Tolerance," "Respect/Gratitude" and "Compassion."

"Courage" is defined as doing the right thing in the face of difficulty and following your conscience instead of a crowd. Chief Financial Officer Tonya Crosby provided a brief update on the impact fee survey.

# Other Matters for Board's Information

General Counsel Wendy Cartledge provided an update on Administrative Rule SS-42 (Student Wellness) and addressed the Board's questions.

Chief Operations Officer Robert Oetting introduced the new Director of Transportation, Eldridge Black Jr., and provided an update on the Community Project Review Committee.

Director of Grants Management Terry Bennett presented a proposed BCSD 2019-2020 calendar and addressed the Board's questions.

# **Board Business**

Board member Rachel Wisnefski read a statement and made a motion to include a contingency funding mechanism for the construction of RRA additions through 8 percent funds only in the event that a November 2019 referendum does not pass or come to fruition, barring any significant reductions to the District's 8 percent borrowing capacity between now and November. Board discussion. Motion failed.

Motion to accept the donation of a sculpture piece titled "Beach Umbrella" from Casey Schachner in the amount valued at \$12,000 to Hilton Head Island School for the Creative Arts (approved).

Ms. Crosby reviewed the time and attendance system proposal and addressed the Board's questions. Motion to approve the purchase of a time and attendance system in an amount not to exceed \$400,000. Board discussion. Motion approved.

Motion to approve the Board of Education of the Beaufort County School District authorizing the Superintendent (or in the absence of the Superintendent, his/her designee, and/or the Chief Instructional Officer/Chief Financial Officer) to apply for, sign, submit and administer federal, state, local and foundation grant applications and cooperative agreements for the 2019-2020 school year (approved).

Ms. Crosby provided background on federal E-rate funds. Motion that the Beaufort County Board of Education (Board) authorize the filing of E-rate Funding Year 2019 applications for eligible E-rate Category 1 Services, and that by doing so, the Board acknowledges it will budget sufficient funds to pay for the District's share of services not supported by the E-rate Program (approved).

Motion for Board Members to have the option to have mobile devices. Board discussion. Motion approved.

# **Public Comment**

A community member reminded the Board about the K-8 discussion in regard to a comprehensive plan. A parent reminded the Board of their discussion at the January meeting regarding contingency funds and spoke about the comprehensive plan. A community member asked Board members to speak into their microphones during meetings. A community member suggested closing underutilized schools in the northern part of the county.

Ms. Robine noted School Counselor Week and shared information about a Rally for Reform on February 11 in Charleston. Board member Earl Campbell shared more details on the rally.

Motion to adjourn approved. Meeting adjourned at 9:50 p.m.
